

*Organizational Minutes Of Board of Directors
Of Woodsboro Education Foundation*

November 10, 2025

A regularly scheduled meeting of the Woodsboro Education Foundation was held Monday, November 10, 2025 after duly notifying the Board of Directors as stated in the organization's bylaws. The meeting convened at 5:32 pm in the Woodsboro High school Library with President Bobby Blaschke presiding.

The following board members were in attendance: Bobby Blaschke, Pam Harris, Leslie Garza, Beth Niemann, Irma Ramirez, Libby Myers, Denise Poland and Jerome Schubert.

A copy of the of the minutes from the meeting held on October 13, 2025, were distributed. A motion was made and duly seconded to approve the minutes as submitted. The motion was approved unanimously by the board members present.

President Blaschke took a moment offer our monthly motivational quote and thank new donors and Leslie gave a district report.

Kasie, Pam, Denise and Beth gave committee reports

Leslie reported that the staff and students were all excited to move into the new elementary school. The gym is expected to be complete in about a month. The new school features a pod cast room, a mini print shop and the library has a lot of space for books and learning. The varsity football team advanced in the playoffs.

Kasie presented the income statement through September 2025. A motion was made to approve the financial report as presented. All board members present were in favor. She reported that we currently have a bank balance of \$63,000.

Pam continues to focus on NYE sponsorships. She received \$500 from Arron's Lawn Service and \$250 from Brian Niemann Insurance. Pam distributed letters to board members to share with potential sponsors.

Denise reported that we did receive the \$5,000 HEB grant for our NYE event. Kasie is also inquiring about sales tax benefits from local hotels if WEF guest stay at their hotel for our event.

Tonya's next focus is on sharing photos of grant recipients and our new elementary school.

Beth is working hard to finalize NYE event details. She is getting bid from Greenhouse Cleaners to have reusable banners made to highlight our sponsors with a photo set up at the event. Denise is working on dinner, dessert and auction cards. Food, supplies and entertainment is taken care of. Pam gave an update on auction items. Tonya will post on Facebook in the weeks leading up to the event. 2026 Spring Bingo is set for April 25th at Padilla Hall. Hamburger meal will be included.
