

*Organizational Minutes Of Board of Directors
Of Woodsboro Education Foundation*

September 8, 2025

A regularly scheduled meeting of the Woodsboro Education Foundation was held Monday, September 8, 2025 after duly notifying the Board of Directors as stated in the organization's bylaws. The meeting was convened at 5:34 pm in the Woodsboro ISD Admin Building with President Bobby Blaschke presiding.

A copy of the of the minutes from the meeting held on June 9, 2025, were distributed. A motion was made and duly seconded to approve the minutes as submitted. The motion was approved unanimously by the board members present. Note that there was no July WEF board meeting.

Leslie gave a brief district update. The construction is going well. The transition to the new building is expected to take place mid October.

Bobby, Kasie and Pam, Tonya, Beth and Cindy gave committee reports.

Bobby gave a brief update on the Coastal Bend Education Foundation Network convention. He came back with a few good ideas and he plans to attend annually. Bobby asked to review the 2025 scholarship status. All recipients have received their checks.

Kasie provided our bank balance. She also presented the income statement through August 2025. A motion was made to approve the financial report as presented. All board members present were in favor. The current bank balance is roughly \$54,000

Pam's current focus is on getting Homecoming bingo sponsors. We have received a few donations from people she has reached out to.

Tonya rolled out the monthly donation option on our website. We have had two people enroll to make monthly contributions to WEF. We have had 123 people mark "interested" in our Homecoming Bingo on our Facebook page. Tonya also worked with Refugio Sports Network to create a commercial style ad that will be aired during live streaming of Woodsboro sports events.

Planning for the Homecoming bingo continues. All is going as planned. A motion was made to order the appreciation gifts for the New Years Eve event. The motions was approved by all board members present. We will order cups that will be given to NYE table sponsors.

Cindy presented the two principal grants. Mrs. Kovar applied for a grant to fund a teacher incentive program that she will implement on her elementary campus. Her grant was in the amount of \$966.29. Mr. Casteneda applied for a grant in the amount of \$920.96 to purchase prizes for his Level Up program that recognizes High School students and staff for their good work. A motion was made to approve both grants. The motion was approved by all board members present.

The board verified the time and date of our next meeting, which is Monday, October 13, 2025, at 5:30pm in the High School Library.

There being no further business, a motion was made and duly seconded to adjourn the meeting. The meeting concluded at approximately 6:37 pm.
