

**Organizational Minutes Of Board of Directors
Of Woodsboro Education Foundation**

January 12, 2026

A regularly scheduled meeting of the Woodsboro Education Foundation was held Monday, January 12, 2026, after duly notifying the Board of Directors as stated in the organization's bylaws. The meeting convened at 5:35 pm in the new Elementary school with President Bobby Blaschke presiding.

The following board members were in attendance: Bobby Blaschke, Pam Harris, Beth Niemann, Cindy Clendennen, Toni Rodriguez, Leslie Garza, Eric Pipkin, Irma Ramirez, Jerome Schubert, Kasie Mundine and Kathy Albert. Also attending is the meeting was volunteer, Missy Bingenheimer.

A copy of the of the minutes from the meeting held on December 8, 2025 was distributed. A motion was made and seconded to approve the minutes as submitted. The motion was approved unanimously by the board members present.

Mrs. Garza gave a district report

President Blaschke took a moment to offer our monthly motivational quote and thank new donors. President Blaschke specifically recognized the Dennis Hennek Foundation and their gift of \$10,000 that was presented at the New Year's Eve event. DHF and WEF share values and have aligned missions. Both organizations share a deep commitment to investing in education.

Kasie, Pam, Beth and Cindy gave brief committee reports.

Kasie presented the income statement through December 2025. A motion was made by Irma and seconded by Cindy to approve the financial report as presented. All board members present were in favor. Kasie also presented the 2026 budget. Pam made a motion to approve the budget as presented. A second was made by Leslie and all board members present were in favor.

Pam gave a brief report. We discussed a "tier level" criteria for partnerships. Toni agreed to work with Denise to create a sponsorship/partnership package to roll out in 2027. All board members present agreed that donors contributing \$1,000 or more, including event table sponsors would qualify to be recognized as a partner of WEF.

Tonya was not present but requested more information regarding "partners". We discussed that in Pam's report and will get the info to Tonya to share on our website and Facebook page.

Beth wrapped up the NYE event. The event brought in over \$35,000. The majority of the thank you notes have been sent. Toni will work to send out the remainder of the thank you notes. Our next WEF event will be the Spring bingo which will be held on April 25th. The committee will begin planning for that event next.

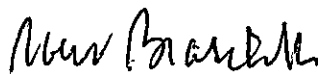
